13. Speed Watch/Speed Signs

The public notices had been put up informing residents that speed signs were to be installed at the junction of Oakfield Road and in The Street on the A272. Providing no objections are received, organisation of the purchase and installation of the signs will proceed.

14. Neighbourhood Planning Update

The Horsham District Council Regulation 16 consultation closed on 11 February 2021 and all responses have been considered by both HDC and the independent Public Examiner. A clarification note has been received from the examiner only raising detail points of understanding or language clarification. Mr Hooper had prepared a draft response and was awaiting feedback from HDC and the CNP steering group. The public referendum was still expected to be held in May 2021.
